

Welldoc & UnitedHealthcare – Sweepstakes

OFFICIAL RULES

SPONSOR

By participating in this Sweepstakes, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of the Sponsor, which shall be final and binding in all respects.

Sponsor reserves the right to disqualify any entries by persons determined to be tampering with or abusing any aspect of the Sweepstakes.

PRIZES AND ODDS

The winner will be contacted and notified by Welldoc by email or telephone on or about 15 days following the drawing date. The prize will then be mailed to the winners. Odds of winning depend on the number of eligible entries received.

WINNER NOTIFICATION AND ACCEPTANCE

The winner will be notified by email or telephone. Sponsor has no liability for any winner notification that is lost, intercepted, or not received by a potential winner for any reason. If, despite reasonable efforts, a potential winner does not respond within ten (10) days of the first notification attempt, or if the prize or prize notification is returned as unclaimed or undeliverable to such potential winner, such potential winner will forfeit his or her prize and an alternate winner may be selected.
